THE JAGAN NATH UNIVERSITYADMISSION POLICY

1. Introduction

- 1.1 The University has been established in 2008 by the Government of Rajasthan and recognized by University Grant Commission under Section 2(f) of the UGC ACT. The University has been accredited with Grade 'B' (Good) by National Assessment and Accreditation Council (NAAC) and is also a member of the Association of Indian Universities (AIU). The University is running various UG /PG Programs with the approval of the concerned regulatory bodies including Bar Council of India (BCI), Council of Architecture (COA), National Council for Teacher Education (NCTE), Pharmacy Council of India (PCI) etc.
- 1.2 With an aim to impart quality education and to make the University as one of the best Centre of Excellence for higher studies and research, the University has developed excellent physical and academic infrastructure, designed latest curriculum, improved teaching methodology, recruitment of best talent as faculty, industry interaction, having a research base in all areas of studies and creation of brand image among the corporate world which is eventually be the place where the students of the university would find their placements.

- To maintain regional, professional and gender diversity. In the light of the broad principles of the University as spelt out above, the University welcomes students from all the continents of the globe, especially from Asian countries to join the rolls of the University.

1.4 Applicability

The provisions of the Policy Document for The Jagan Nath University Admission Policy will be applicable w.e.f the date of it's approval by the BoM and it will replace the earlier policy of the University in this regard and this policy is applicable to all the admission seekers, seeking admissions in various programs run by the University.

2. Academic Programs

- 2.1 The University currently runs various Diplomas, Under Graduate, Post-Graduate and Ph.D Progarmmes with the prior approvals of the Regulatory Bodies/ Academic Council/ Board of Management as per Annex.-I under various faculties as follows:
 - i. Faculty of Engineering & Technology
 - ii. Faculty of Management
 - iii. Faculty of Law
 - iv. Faculty of Science
 - v. Faculty of Education
 - vi. Faculty of Medical, Para Medical & Allied Health Science

3. Admission Committee

- 3.1 There shall be an Admission Committee in compliance to the Section 32 Jagan Nath University, Jaipur Act 2008 and as per Section 36 of the University Statutes to regulate the Admissions of the University. The committee shall consist of the following:
 - (a). Vice Chancellor/President, Chair Person
 - (b). Pro- Vice Chancellor/Pro-President
 - (c). Deans of the Faculties/ HoDs of the Departments
 - (d). Proctor
 - (e). Chief Warden/ Hostel Superintendent
 - (f). Controller of Examinations
 - (g) Registrar, Member Secretary
 - Two-fifth of the members will constitute the quorum.
 - There shall be at least one meeting of the admission committee in a year.

3.2 Functions

- The primary function of the Admission Committee is to regulate the entire admission process through a transparent and holistic approach.
- ii. To draw the merit lists of candidates applying for admission and the categories of candidates for which any seats are to be reserved and/or to whom any weightage is to be allowed in a transparent manner.
- To propose the numbers of seats for each program to Academic Council and Board of Management in the beginning of each academic session in accordance with the availability of the teachers and the infrastructure and as per the approved intake the Regulatory Bodies.
- iv. To ensure the implementation of the reservation policy of the State Government.
- To ensure the implementation of merit cum means scholarship at the time of admission.
- vi. Such other matter as may be referred from time to time.

3.3 General Guidelines

- The University shall be open to persons of all gender, irrespective of race, creed, caste, or class.
- ii. Admission in the University shall be open to Indian citizens or Non-Resident Indians. However, the University shall also admit foreign students as per the guidelines of State and having eligibility and equivalence as per norms of regulatory bodies.

- Provided that titles, eligibility criteria and duration of programs shall be strictly as per the specifications of degrees prescribed in UGC Regulations.
- Provided further that lateral entry shall be allowed only as per the provisions of regulations of regulatory bodies.
- Provided further that equivalence for entry level eligibility shall be decided as per Association of Indian Universities (AIU) for foreign students.
- Provided further that no students passing eligibility examination from unrecognized board or unrecognized university shall be allowed admission or grant of degree by the university.
- Admissions in all programmes of the University shall be made as per provisions of section 32 of the University Act.
- iv. For NRI/Foreign students' admission shall he made on merit of marks obtained at the qualifying examinations as per provisions of regulatory bodies.
- v. Where admissions are to be given by an agency determined by State or Central Government, the University shall follow the norms and procedure prescribed for such admission program.
- vi. The University where necessary, may also consider score/merit in Entrance Tests conducted by any other State level /National level agency appointed by the relevant government for admission to any program.
- vii. Such students enrolled by duly constituted University in the country may be allowed to migrate to this University with the approval of Academic Council as per provisions of Regulatory Bodies.

4. Admission Process

The admissions will be made on the basis of merit. The lists of admitted students to various programs will be prepared in accordance with this policy. The following steps are ovolved in the admission process:

4.2 Eligibility Criteria

- ➤ Jagannath University, Jaipur offers various Certificate/Diploma/UG Degree/PG Degree in various streams e.g. Engineering, Management, Science, Law, Architecture, Physiotherapy, Pharmacy, Agriculture & Education and Ph.D in various streams viz. Engineering, Management and Law streams.
- ➤ All candidates who have cleared 10+2 with minimum 50% marks [45% for SC/ ST/ State OBC (Non-Creamy Layer) candidates] fulfill Jagan Nath University's eligibility criteria for all UG Programmes.
- The candidates who have obtained at least 50% marks [45% for SC/ ST/ State OBC (Non-Creamy layer) candidates] in their graduation meet Jagan Nath University's eligibility criteria for PG programme admissions.
- Candidates appearing at the final examination of the qualifying degree may also apply. Such candidates, if selected, will be given provisional admission and will have to submit the evidence of passing the qualifying examination within two months of the start of the session, failing which their admission will be automatically cancelled.

4.3 Admission Procedure

4.3.1 Admission Procedure in UG/PG Programme for Indian Students

Admission for various Under Graduate and Postgraduate Programs is done on merit basis. Selection for admission to various Under Graduate and Postgraduate Programs is determined on the basis of the qualifying examinations with any entrance examination conducted by State/Central Agency/Jagan Nath University Entrance Examination(JUEE) followed by Group Discussion & Personnel Interview.

4.3.2 Required Documents for Admissions in UG/PG Programme for Indian Students

The following documents are to be submitted by the candidate at the time of admission.

- ➤ 10th & 12 marks sheet & certificates (Photocopies self-attested)
- 3 Photographs
- Transfer Certificate or Migration(Original)
- Date of Birth certificate
- Graduation Mark Sheet (Photocopy self-attested) (for PG Students Only)
- Adhaar card copy(Photocopy)
- Character certificate(Original)

4.3.3 Admission Procedure for Foreign Students

- > Students from Nepal and Bhutan can pay fee in Indian Rupees. Students from other countries will deposit fee in as prescribed in US \$ in the prospectus.
- There is no entrance test for foreign students. Their suitability to the program would be based on the qualifying exam marks and an aptitude assessment.
- ➤ All foreign nationals with foreign qualifications are required to submit the Equivalence certificate from Association of Indian Universities (AIU) with the application form.
- All the Foreign Students must have valid medical Insurance before joining the University.
- > Student Visa is required to join Undergraduate Program, Post-Graduate Program.
- Candidates can apply to any of the programs offered by Jagan Nath University in any one of the two modes: Apply online or Download and take out the print out of the admission application form.

4.3.4 Required Documents at the time of Admissions (for Foreign Students)

The following documents are to be submitted by the candidate at the time of admission.

- Certified (English translated) copy of the marks/ grade sheet of the qualifying examination (if available)
- > Certified copy of the grade equivalence to marks by the respective boards.
- > Proof of NRI status of the student/ parents/ sponsor (if applicable)
- Copy of the passport (Personal detail pages)
- > Latest passport size colour photograph in addition to one affixed on the application
- Migration Certificate (if available at the time of application)

4.4 Procedure for Depositing the Fees

Candidates are advised to deposit the fees at the university office with Demand Draft/
Cheque in favor of <u>JaganNath University payable at Jaipur</u> or make payment through online ICICI Easy pay from the University web site. Fees is to be paid in two equal Installment on 31 July and January 31st of each year failing which the penalty will be charged. For detailed Fee Structure, please refer to our website

5.1.1 Reservation Policy for Kashmiri Migrants and Kashmiri Pandit / Kashmiri Hindu Families (Non-Migrants)

The Reservation Policy for Kashmiri Migrants and Kashmiri Pandit / Kashmiri Hindu Families (Non-Migrants) living in Kashmir Valley for admission in Higher Educational Institutions has been complied by the University as per MHRD letter no. 3-4/2017-NER are as follows:

- Relaxation in cut-off percentage up to 10% subject to minimum eligibility requirement.
- Increase in intake capacity up to 5% program-wise.
- Reservation of at least one seat in merit quota in technical/professional institutions.
- Waiving off domicile requirements for Kashmiri Migrants only. Kashmiri Pandit / Kashmiri Hindu Families (Non-Migrants) living in Kashmir Valley need domicile certificate.

6. Scholarship Policy

The University offers two categories of scholarships, as follows:

- Merit cum Means by the University.
- ii. Balika Shiksha Sambal Yojna
- iii. Scholarship by the State / Central Government.
- iv. Merit based scholarship
- Any other scholarship offered from time to time

6.1 Merit cum Means Scholarship

This scholarship is extended to the students at the time of the admission by the University purely based on the marks obtained in the qualifying examinations as follows:

- The students securing 90% & above in aggregate (All Board Exam.) are exempted from tuition fees.
- Students securing 87.5% to below 90% in aggregate (All Board Exam.) are exempted from 75 % of tuition fees.
- Students securing 85% to below 87.5% in aggregate (All Board Exam.) are exempted from 50 % of tuition fees.
- ➤ Students securing 80% to below 85% in aggregate (All Board Exam.) are exempted from 25 % of tuition fees.

- ➤ Students securing below 80% in aggregate to 75% (All Board Exam.) are exempted from 10 % of I year tuition fees.
- 10% additional scholarship is given to the Girl Candidates over and above the sanctioned scholarship amount.
- ➤ The scholarship is not applicable in some courses as LLM, Lateral Entry, Ph.D & in Migration cases.
- 6.2 Under CSR initiative of the University "Balika Shiksha Sambal Yojna", the University is giving free education to five BPL girl students on first come first basis. For detail please refer Annexure-I.

The admission committee will prepare a list of eligible candidates which will be placed before the Academic Council for it's recommendation to the Board of Management of the University for final approval which shall further be communicated to the respective departments.

6.3 Scholarship by the State / Central Government

There are various types of scholarships extended to the SC/ST/OBC/Minority/Physically Handicapped etc. are available as per State / Central Government Schemes. The desired students may apply to the same as per the detailed guidelines laid down in

Annexure-II.

6.4 Merit Based Scholarship

The University offers Merit Scholarship to their students based on the performance of End-Semester Examinations on yearly basis.

- > The Best Performer in both semesters Marks obtained in both the even and odd semester will be taken into consideration for award of scholarship every year.
- > Student must be topper in all the branches (in case of faculty having branches i.e. Engineering & Technology) with 1st Division and he/she must clear all subjects.
- > The student shall be awarded a cash amount of Rs. 5000 with certificate of Merit.

6.5 Any other Scholarship offered from time to time

It may include any scholarship offered through University Chairs, Memorial Scholarships etc. Rs

7. Migration Policy

Migration applications received by Admission Cell, shall be forwarded to respective Deans/HoD of the Faculty/Department for eligibility & equivalency check. The application shall be further considered by the Vice Chancellor/President and finally approved by the Academic Council of the University.

The Migration shall be accepted subject to the following conditions:

- 1. Migration can't be claimed as a matter of right
- The candidate must possess the minimum qualification prescribed for admission to the programme.
- 3. Migration will be allowed strictly as per norms of the Regulatory Bodies.
- 4. Migration shall be allowed subject to availability of seats in applied programme.
- The candidate must produce Migration Certificate/No Objection Certificate from the University/Institute from which he/she is migrating.
- 6. The candidate must pay the Migration Fee Rs. 2000/-
- 7. The Application Form should be supported by the Character Certificate from the Institution last attended and the mark sheet of the semester(s) in which he/she appeared in the examinations from the migrating University/Institute.
- 8. If the migration is sought in an even semester, the candidate will be required to pay the semester fee of the previous odd semester along with the fee of even semester.
- 9. The programme structure of Jagan Nnath University and previous Institute/University would be checked. In all the similar subjects, the marks obtained (both internal and external) would be taken into account as per Jagan Nath University Examination Policy. However, in all the non-matching subjects the candidate has to reappear in Jagan Nath University Examination as and when scheduled.
- 10. If a candidate passed any subject(s) in his previous Institute/University which is in a different semester in Jagan Nath University programme structure, then the credit may be given to the candidate for that paper in particular semester e.g. If a student has already covered Computer Fundamentals in Sem.-I in his previous Institute/University but the same subject is there in Sem.-IV as per Jagan Nath University programme structure, then the credit of this particular paper may be given to the student in Sem.-IV.
- 11. The Degree of the University from where the student is seeking migration should be recognized as equivalent to the degree of Jagan Nath University.

8. Withdrawal / Refund Policy

The fees are refundable as per the UGC guidelines issued from time to time.

9. **Cancellation of Admissions**

Jagan Nath University reserves its right to cancel the admission of students under any of the following circumstances:

- If the candidate fails to produce the proof of the minimum qualification.
- If the candidate fails to join a particular program by the stipulated date.
- If the fee is not deposited by the stipulated date
- If the candidate is found to be involved in the malpractices or any other issues regarding indiscipline.

Jagan Nath University Balika Shiksha Sambal Yojana Regulations, 2013

Background

The Hon'ble Chief Minister of Rajasthan along with some Union and State Ministers visited Jagan Nath University Campus to Inaugurate the University Auditorium on May 31, 2013. The Chief Minister while addressing a gathering of more than 650 people consisting of the senior functionaries, faculty members, non-teaching staff, students of the University and many distinguished guests mentioned about the tremendous progress made by the University in a short period of five years since its establishment in the rural belt of Jaipur.

On this occasion, the University took a lead and announced Jagan Nath University Balika Shiksha Sambal Yojana for the benefit of 5 BPL Girl students. Accordingly, these Regulations.

1. Short tile, commencement and application:

- (1) These Regulations may be called Jagan Nath University Balika Shiksha Sambal Yojana Regulations, 2013.
- (2) These Regulations shall come into force at once.
- (3) These regulations shall apply only to the girl students of Rajasthan domicile, who fall under Below Poverty Line category.

2. Procedure of Selection:

- (i) The benefits of the scheme shall be available only to 5 girl students of Rajasthan domicile who belong to the BPL category and submit the requisite certificates from the competent authority.
- (ii) The girl students falling under clause (i) above must apply and submit the admission form only for this category and claiming the benefit of the scheme.

- (iii) The total of 5 girl students of BPL category of Rajasthan domicile will be given the benefit on first come first basis. The decision of the Admission Committee in this regard shall be final.
- (iv) The students for this benefit will be selected on the basis of *inter se* merit in their qualifying examination. In case of a tie, the merit will be determined on the basis of marks in 10th class. If still there is a tie, the student senior in age will be considered. The decision of the University shall be final.

3. Benefits of the Scheme:

- (i) The girl students selected under the scheme will be entitled to free education in the course admitted and free boarding and lodging in Hostel.
- (ii) At any stage, if it is found that a girl student has submitted fake/ forged certificates to claim the benefit of the scheme, her admission will be cancelled ab initio and the legal action will be taken as per law.

4. Review of Scheme:

The University has the right to review the scheme after the end of each academic year and to decide as to continue the scheme in future with or without any modification, as it deems fit.
