BAN ON SINGLE USE PLASTIC IN JAGANNATH UNIVERSITY, JAIPUR CAMPUS

Plastic Waste has been known to be one of the major reasons for environmental pollution and is one of the biggest environmental concerns. It exerts irreversible adverse impact on soil, water, and health of all living beings at large. Thus plastic waste disposal system is a challenge.

Thus, in adherence to the "Jagannath University, Environment Consciousness and Sustainability Policy", it is hereby informed to all concerned that the competent authority of Jagannath University, Jaipur; in continuation of efforts towards maintenance of a healthy and sustainable environment has decided to undertake the following steps to put ban on single use plastic material on campus.

- 1. Ban on use of single-use plastics in canteens, campus premises, hostels, etc.
- Keep signboards at various places to give wide publicity to ban on use of plastic/polythene on the campus.
- 3. Avoid use of plastic water bottles, polyethylene bags and encourage use of alternative solutions like cloth bags, paper bags etc.
- 4. To encourage all students/staff members to avoid bringing non-biodegradable plastic items on the campus.




