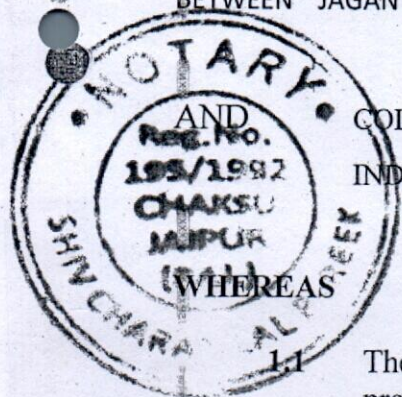

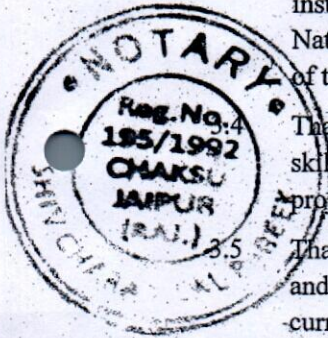

## OBJECTIVES OF THE PARTIES

- 2.1 To provide judicious mix of skills relating to a profession and appropriate content of General Education for B.Voc. (Hospitality, Catering and Tourism)
- 2.2 To ensure that the students have adequate knowledge and skills, so that they are work ready at each exit point of the programme.
- 2.3 To provide flexibility to the students by means of pre-defined entry and multiple exit points.
- 2.4 To integrate NSQF within the undergraduate level of higher education in order to enhance employability of the graduates and meet industry requirements. Such graduates apart from meeting the needs of local and national industry are also expected to be equipped to become part of the global workforce.
- 2.5 To provide vertical mobility to students coming out of 10+2 with vocational subjects.

## WHEREAS THE SECOND PARTY UNDERTAKES :

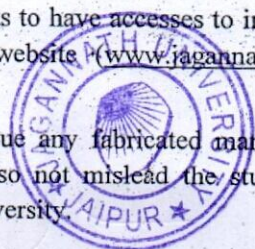
- 3.1 That they had voluntarily approached the first party for providing the skills components in B. Voc. (Hospitality, Catering and Tourism) Course to be run the by Jagannath University Jaipur (the First Party) with effect from Session 2017-18.
- 3.2 That the B.Voc. (Hospitality, Catering and Tourism) course will be of 3 years duration (under Semester Scheme). Both the parties agree that for running this course following all the norms prescribed by the UGC for the said Program.
- 3.3 That the practical/hands-on portion of the skills development components of the curriculum should be transacted normally in face to face mode within the institution of the second party which will be a Hotel industry partner of Jagan Nath University. The skills development components shall not be less than 60% of the curriculum.
- 3.4 That the second party to provide necessary infrastructure such as - classrooms, skill components, technologically equipped laboratories, facilities for field work, project work, on the job training, etc. required for the Program.
- 3.5 That the second party to conduct the program strictly as per the UGC Guidelines and Norms and Jagan Nath University Rules & Regulations and course curriculum laid down from time to time.
- 3.6 That the second party to provide skill education as per the scheme of curriculum and the Examination Regulation laid down by the First party from time to time.
- 3.7 That the students shall be provided with internship and placement assistance by the Second Party.
- 3.8 That the second party will make a fair and true representation to the aspirants about all the details contained in the information brochure of the university. The second party will not make any false or misleading representation to the students.
- 3.9 That the second party will tell the students to have accesses to information given in the university prospectus and the website ([www.jagannathuniversity.org/](http://www.jagannathuniversity.org/)) before taking admission.
- 3.10 The second party will not make/issue any fabricated mark sheet, degree, provisional and other certificates and also not mislead the students about the examination scheme and policy of the university.

WHEREAS THE FIRST PARTY UNDERTAKES :

- 4.1 That the general education components which should not exceed 40% of the total curriculum will be taken care of by the First party. The first party will impart general education in the University.
- 4.2 That the first party will be responsible for conducting the examinations, evaluation and assessments of the Students. The first party will be responsible for issuing the degree for B.Voc. (Hospitality, Catering and Tourism) as per the UGC's norms, on the successful completion of the 3 years course by the Students and issuing mark-sheets as per the norms of the UGC. The University may also issue certification levels leading to Diploma/Advanced Diploma in the said course as under :

Award	Duration	Corresponding NSQF level
Diploma	1 Year	5
Advanced Diploma	2 Years	6
B.Voc Degree	3 Years	7

WHEREAS BOTH THE PARTIES UNDERTAKE :

- 5.1 It is mutually agreed that the sharing of tuition fee between the first & the second party will be 40% and 60% respectively.
- 5.2 The accounting will be done by 3<sup>rd</sup> of every month
- 5.3 The course contents and the examination regulations shall be followed by the second party as approved by the Board of Studies/Academic Council/Board of Management of the University (First party).
- 5.4 To fulfill the aims of this MoU both of the parties shall by mutual consent decide as to the interpretation of the contents of the MoU, in writing.
- 5.5 This MoU may be varied or amended by mutual consent of both the parties, in writing, and such variation or amendment shall become part of this MoU upon the giving of the consent of the parties.
- 5.6 This MoU shall commence on the date this document is admitted by the parties and shall remain in force for a period of 03 years. The MoU may be extended by mutual agreement.

That all legal disputes shall be subject to the jurisdiction of Jaipur court.

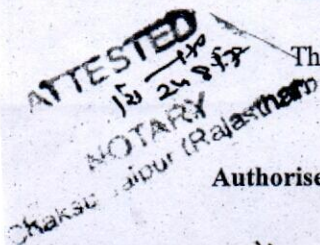
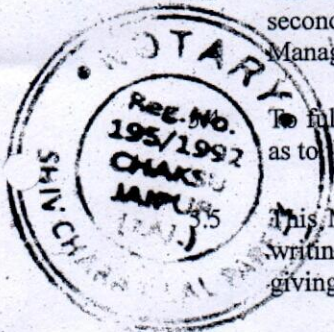



Hospitality Administration**

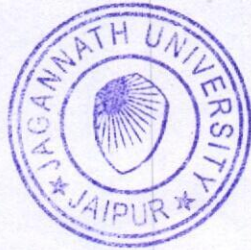

Accordingly, students admitted in this program were attending general component subjects in the university where as they were attending skills component subjects at CHA. This program was running in modular form e.g.; students completed 1st year was entitled for Diploma in Vocational, for 2nd year it was Advance Diploma in Vocational and in 3rd year it was Bachelor of Vocational.
