



RESTRCITED ENTRY OF VEHICLES IN JAGANNATH UNIVERSITY, JAIPUR CAMPUS

To maintain the quality of air and control the level of vehicular emission in and around Jagannath University, it is hereby informed to all concerned that the competent authority of Jagannath University, Jaipur; has decided to undertake the following steps to restrict entry of vehicles in campus:

- All vehicles coming to campus (both main campus and Sitapura campus) shall be parked at the designated parking and not at any other vehicles in the campus. This rule is applicable to all: Visitors, Staff and Students.
- 2. Service Vehicles will be allowed on campus only after permission from the competent authority.
- Vehicles of staff, students and visitors shall be allowed beyond the designated parking, only after permission from competent authority.

All staff and students are required to cooperate in this regard by following the above instructions carefully. The above measure is a part of Green initiatives of Jagannath University, Jaipur.
