Loki, a recent MBA graduate from the Institute of Management Studies at the age of 25, had an impressive academic record, consistently achieving gold medals in his secondary school, undergraduate, and postgraduate studies. Despite his academic excellence, he was struggling to secure a job that met his aspirations.

One day, while taking a break at a local tea stall and having a cigarette, Loki noticed a well-dressed individual named Goggy. He had an ID card from a prominent multinational corporation and seemed approachable. Loki decided to strike up a conversation with him and asked if he could help him apply for a job at his company. Goggy shared his own journey to getting the job and suggested Loki check out a place called "Naukridekho."

Intrigued by Goggy's advice, Loki decided to explore this option. Naukridekho was an organization that claimed to assist job seekers in finding employment opportunities. They offered services such as enhancing CVs with fake experience letters and diploma certificates, which could make a candidate's profile more appealing to potential employers. Additionally, Naukridekho promised to arrange interviews with MNCs. However, their services came at a cost.

When Loki arrived at Naukridekho, he met with a person named Pinkul, who was sitting at the reception. Pinkul explained the entire process to Loki, assuring him of a job with a minimum package of 10 lakhs per annum within three months. However, Pinkul requested a fee of 50,000 to facilitate the entire process.

Loki, eager to secure a job, agreed to pay the fee and deposited the full amount in cash the following morning. However, when he requested a receipt as proof of payment, Pinkul informed him that they did not provide receipts for illegal activities. Loki reluctantly accepted this and returned home.

Two weeks later, Loki returned to the Naukridekho office, feeling concerned about the lack of communication from the organization. He approached the reception desk, and find a new receptionist on duty. He inquired about the status of his job application and asked for guidance on the next steps in the process.

The new receptionist, after some discussion, informed Loki that there was no record of his enrolment with their organization. This revelation shocked Loki, and he began to argue with the receptionist, insisting that he had indeed paid a substantial amount to Naukridekho. In response, the receptionist requested to produce a receipt as evidence of his payment.

After a thorough discussion, it became evident that Pinkul, the person Loki initially dealt with, had committed fraud. She had fled away with the money Loki had paid, leaving him in a difficult and unfortunate situation.

On the same night, Loki, feeling low, had a drink with his friend, Ferry. Loki wanted to find Pinkul, so he searched for her on a social media platform called "Telephonebook." He found her profile and asked Ferry for ideas on how to get back at her.

Ferry suggested him an idea. He used an AI tool called "FAT GPT" to manipulate a photo of Pinkul, making it appear inappropriate. Then, Ferry told Loki to send this edited photo to Pinkul and try to pressure her. So, Loki sent the photo and asked Pinkul for one night stand with him and his friend Ferry.

Pinkul was upset and immediately blocked Loki and immediately told her fiancé, Zafer, about the incident. Zafer was furious and, along with four of his friends, went to Loki's place. When Loki opened the door, Zafer started hitting him. Ferry tried to help Loki, but Zafer's friends started to beat him up. The situation got worse, and Zafer felt so insulted that he Emasculated Loki with a knife and went back.

Loki's dad rushed him to the nearest hospital, where he remained unconscious for 15 hours. The police filed a case for grievous hurt and began searching for all five people involved. After 30 hours, they arrested all of them. Zafer, being the son of a Zombian diplomat, got bail in just two hours along with his friends.

A week later, the police filed their final report, and the Court of Session acquitted all of them on benefit of doubt. This was a huge disappointment for Loki, who had lost faith in the system. He decided to take matters into his own hands and seek his own revenge.

On the judgement night, Zafer threw a party with his four friends, and Pinkul was also there. They were all having a good time, dancing, drinking, and unfortunately, using illegal drugs. At around 12:30 AM, Loki and his friend Ferry unexpectedly showed up at the party.

Things took a tragic turn when Loki hit Zafer on the head with an iron rod, and Zafer sadly lost his life. Ferry then used a gun to harm all four of Zafer's friends. This left Pinkul as the only one remaining, and she was very frightened.

Loki asked ferry to brutally rape Pinkul and he made a video of the same. After rapping her Video camera handed over to Ferry and Loki forcefully inserted 20-inch rod inside the Pinkul's private part. Pinkul got unconscious due to heavy pain and torture. They left her there with Iron Rod inside her, and without any cloth on her. After leaving the place Loki uploaded the video on porn websites and social media plat forms with a tag line, “don't depend upon system for justice”.

On very next morning Zafer's Servant Chanduram came and see the doors of house are open. He entered inside the house and see blood is there on the floor everywhere. Zafer and his friends are dead and Pinkul was lying on the floor without any cloth and blooded iron rod inside her private part. He immediately ran out for asking help. All of them took to the hospital. Doctor declared all of them dead except Pinkul. She died after 20 Hours on ventilator.

A FIR was registered by Zafer's Father in Police station for Murder, gang rape, Grievous hurt, House Trespass at night. Police tried to find Loki and Ferry but failed. After three days the case was transferred to CBI. Meanwhile Autopsy report of Pinkul also came which stated that the reason for death is multiple injuries in Vaginal cavity, ovary, uterus and near by parts. She was also intoxicated before death. Some semen samples were also found on vaginal cavity but of Zafer and not of Ferry.

The CBI investigating officer, Mr. D'Souza, apprehended Loki and Ferry approximately 1200 kilometres away from the location of the crime. They were discovered working as laborers on a farmer's property in a village, and they were found in possession of forged Aadhar cards.

Within 30 hours of their arrest, Loki and Ferry were brought before the court. The court granted a four-day police custody period for further questioning and investigation. Throughout this process, the court consistently rejected the bail applications made by both accused.

The police report was officially filed approximately 80 days after the initial arrests. Subsequently, in the following six months, the court deliberated on the case and ultimately delivered its verdict, sentencing both Loki and Ferry to life imprisonment.

Zafer's father, dissatisfied with the previous verdict, filed an appeal in the High Court of Flora, seeking capital punishment for both Loki and Ferry. In their appeal, the

defense argued that there was insufficient evidence to prove that Ferry had raped Pinkul, pointing out the potential for video manipulation using AI tools and the absence of a semen sample in Pinkul's autopsy report. They questioned why the benefit of doubt was not extended to Ferry and Loki, given these uncertainties. Furthermore, the defense contended that the circumstances surrounding the events amounted to revenge under grave provocation, and therefore, the case should not fall under the category of "rarest of rare cases."

The High Court, after careful consideration, chose to uphold the lower court's decision without any alterations. Additionally, they declined to grant a certificate for further appeal to the Supreme Court. This indicates that the High Court found the evidence and legal arguments presented by the defense to be insufficient to reverse the convictions and sentences of Loki and Ferry. The High Court's ruling is a significant legal outcome in this case.

Aggrieved from the decision of High Court, Zafer's father approached the Supreme Court of Insomnia under Special leave Petition.

## MOOT PROPOSITION

### **Legal issues;**

In the present Special Leave Petition (Criminal) following question of law are before the Hon'ble Supreme Court for adjudication: - (Two issues are given, parties are free to frame other issues of their choice.)

1. Whether the Special Leave Petition is Maintainable or Not?
2. Whether the act of Loki and Ferry falls under the ambit of Rarest of Rare Case or not?

### **Note;**

1. Participants are requested to argue on the side of the Petitioner as well as on the side of the Respondents before the “Hon'ble Supreme Court of Insomnia” pertaining to the above case and further elucidate the arguments with appropriate case laws and inputs.
2. The laws of the Insomnia are pari material with laws of the India. The Hon'ble Supreme Court of Insomnia considers the leading common law precedents as being highly persuasive. Hence, all the relevant ancient, modern, texts of Indian laws may be referred for arguing the case.
3. This Moot Problem has been formulated solely for the purpose of this competition for furthering the academic exercise only.

## RULES & REGULATIONS

### **Article 1 – Team Composition**

1. Each team shall consist of 3 members. This number cannot be modified under any circumstances. In case there is two member team then such team shall not be evaluated for best researcher.
2. In case 3 members are participating then there shall be 2 Speakers and 1 Researcher in each team.
3. Each team will have a team code. Teams should not disclose their identity or that of their institution or city, etc., under any circumstances during competition and such disclosure shall invite penalties including disqualification from the Competition directly. The decision for the same shall be at the discretion of the Organizers.
4. Maximum number of teams for the competition shall be 50 and selected on the basis of First come first serve

### **Article 2 – Date and Venue**

The said competition will be held from 06-08 April, 2024 at the Faculty of Law, Jagan Nath University, Sitapura Industrial Area, Near Chokhi Dhani, Jaipur, Rajasthan 302022.

## RULES & REGULATIONS

### **Article 3 – Dress Code**

1. Male: Advocate's attire (black blazer, black trouser, black formal shoes and white formal shirt with black tie) is compulsory. Participants are expected to make their own arrangements regarding the same. Not abiding by the said rule can lead to direct disqualification and the organizing committee will have complete discretion regarding the same.
2. Female: Advocate's attire (black blazer, black trouser, black formal Belly and white formal shirt with black tie) is compulsory. Participants are expected to make their own arrangements regarding the same. Not abiding by the said rule can lead to direct disqualification and the organizing committee will have complete discretion regarding the same.

### **Article 4 – Eligibility Criteria**

1. Students pursuing any three-year or five-year integrated course of the LL.B. degree from any recognized Law college/ University in India by UGC/BCI are eligible to participate.
2. Participant shall carry their college identity card for the purpose of identification during the said competition.

1. All the teams will be provided with a Team Code once after the confirmation of Registration with confirmation of Payment has been completed.
2. Teams shall register with the host college by **11.03.2024**, or registration of First 50 Teams, whichever is earlier before sending the Registration Form and Payment Receipt. Forms will only be accepted if the host has confirmed the Registration formalities.
3. ### **Article 6 – Language**

The said competition shall be in ENGLISH LANGUAGE only. Use of vernacular language by the participants during the said competition is prohibited.

### **Article 7 – Guidelines for Memorials**

Written Submissions Structure: The written submissions must contain the following contents:

1. Cover Page
2. Table of Contents
3. List of Abbreviations
4. Index of Authorities
5. Statement of Jurisdiction
6. Statement of Facts
7. Issues Raised
8. Summary of Arguments
9. Arguments Advanced
10. Prayer

Team Code: The team code must be affixed to the top right corner of the cover page. The code must be succeeded by the side for which the written submission is prepared.

Cover page colour :

1. Petitioner- Blue
2. Respondent- Red

## RULES & REGULATIONS

**Margin:** The written submission must maintain an equal margin of 1 inch on all sides.

Non-compliance will result in a penalty of 1 mark per side of written submissions.

**Font, size and line spacing:** The text font should be Times New Roman or Garamond, size 12 and must be in 1.5 line spacing. Non-compliance will result in a penalty of 0.5 marks per incorrect format of font, size and line spacing with a maximum of 2 marks per page of the written submissions.

**Footnotes:** The footnotes must be in Times New Roman or Garamond font, size 10 and singly spaced. There should be double line spacing between two footnotes.

**The Bluebook:** A Uniform System of Citation (20<sup>th</sup> Edition) should be followed throughout the written submission throughout. Non-compliance will result in a penalty of 1 mark per page. Substantive/Speaking footnotes are strictly prohibited. Non-compliance will result in a penalty of 1 mark per substantive citation.

**Header and Footer:** The font used for the header/footer, if any, shall be Times New Roman or Garamond, size 10, 1 spacing. Non-compliance will result in a penalty of 1 mark per page of the written submissions.

**Page Limit:** The memorial shall not exceed from 40 Pages and minimum shall be 25 pages. No annexures, photographs, exhibits, etc. should be added to the written submission. The written submission shall be marked on a score of 100 marks.

## RULES & REGULATIONS

### **Article 8 – Scouting**

1. Teams will not be allowed to observe the oral rounds of any other teams. Scouting is strictly prohibited. Scouting by any of the teams shall result in disqualification, as per the discretion of the organizers.
2. Any participating team can file a written complaint to the Organizers, regarding the incident of scouting. The Organizers decision shall be final.
3. The researchers will sit with the speakers at the time of orals and shall not attend the rounds of any other team participating in the said competition.

### **Article 9 – Rounds**

Registration for the preliminary rounds and draw of lots will be held on 06.04.2024.

The preliminary rounds will be held on 06.04.2024 comprising of two (2) rounds for each team. In the Preliminary rounds, each team shall appear from both petitioner and respondent sides.

Eight teams shall qualify for the quarter finals.

The quarter finals round will be held on 07.04.2024 The semifinals round will be held on 07.04.2024.

The final round will be held on 08.04.2024.

## RULES & REGULATIONS

### Article 10 – Oral Rounds

In the Preliminary and Quarter final rounds the time slot for each round shall be as follows:

Opening Statement on behalf of Petitioner	5minutes
Opening Statement on behalf of the Respondent	5minutes
Arguments by Petitioner	10minutes
Arguments by Respondent	10minutes
Prayer from Petitioner	5minutes

Therefore, the Petitioner will get a total of 20 minutes and the Respondent will get a total of 20 minutes in the Preliminary rounds. Each speaker shall have to argue at least on one issue. This rule shall apply to the Two (2) rounds comprising the Preliminary round. Each Speaker shall deliver either the opening statement or the final argument in each round.

In the Semifinals and Final round, the time slot shall be as follows-

Opening Statement on behalf of Petitioner	5minutes
Opening Statement on behalf of the Respondent	5minutes
Arguments by Petitioner	15minutes
Arguments by Respondent	15minutes
Prayer from Petitioner	5minutes

### Article 11 – Judging Criteria

The parameters for judging are:

1. Knowledge of facts.
2. Logic and clarity in reasoning.
3. Persuasiveness and deference to court.
4. Proper, articulate and systematic analysis of the issues arising out of facts.
5. Understanding of the laws and procedure.
6. Ingenuity (ability to argue by analogy from related aspects of law) or knowledge of the relevant provisions relating to penal laws.

### **Note:**

Both the teams must be aware about the appellate procedure followed by the courts. Cumulative Eight highest scorer teams in both preliminary round, Shall be selected for quarter finals.

After that, there will be knockout rounds from Quarter finals to final.

### **Article 12 – Awards**

1. Winner - Rs. 21,000 and one-year complimentary subscription for all participants to EBC Learning worth Rs. 14,500 each. Total Value of Rs. 43,500.
2. 1st Runner Up - Rs. 11,000/-
3. Best Advocate - Rs. 5,000/-
4. Best Researcher - Rs. 5,000/-

### **Article 13 – Certificates**

Certificates will be awarded only to the participants during the valedictory ceremony and under no circumstances they will be provided to any of the participants absent during the ceremony. In the event that the participants fail to collect their certificates, no mail will be sent by the host college acknowledging their participation.

### **Article 14 – Accommodation and Meals**

1. The registration amount of Rs.6000/- is inclusive of Registration Amount & Accommodation. The Accommodation shall not be provided by the host Institution in any case before 05 April 11:59 AM and after 09 April 11:59 AM., 2024.
2. Respective team who wishes to arrive a day before the event begins or leave a day after the event ends, needs to pay a regular accommodation amount in addition.

**Note:** Drinking and smoking is strictly prohibited at the place of accommodation & university premises and Non-compliance of this rule will lead to disqualification and the host institution can take action against the team found violating this rule and impose heavy penalty.

### **Article 15 - General Rules**

Each team must prepare memorials for both sides.

Once the memorials have been submitted, no revision, supplements or additions will be allowed.

One advance softcopy in PDF format must reach the organizers latest by 30.03.2024 on [mcc@jagannathuniversity.org](mailto:mcc@jagannathuniversity.org) and upload on this link :

12 Hard Copies (6 copies from each side) of the memorials should reach the organizers latest by 29.03.2024 at the aforementioned address.

### **Article 16 – Miscellaneous**

Case laws that the parties wish to rely on at the time of final arguments shall be submitted in three copies in form of a compendium (one for the judges, one for the other side and one for itself). The source of Judgements should be from a verified database like SCC Online, Manupatra etc.

Opening statement of the petitioner shall be from facts and the issues raised. It shall be necessary to point out the supporting material from the fact sheet herewith provided to sustain the arguments. As far as the respondent is concerned, the opening address shall require them to point out the allegations against them.

Judges are at liberty to ask questions to the Participants on relevant points of law which may arise as per the fact sheet arising during the conduction of proceedings, in order to test the Participant's knowledge of the relevant provisions relating to penal laws.

### NATIONAL MOOT COURT COMPETITION 2023

Last April, we had the distinct pleasure of organizing the "National Moot Court Competition," an event that set a benchmark in the realm of legal competitions in India. The enthusiasm and participation were overwhelming, with an impressive turnout of 72 teams hailing from various corners of the country, each bringing their unique skills and perspectives to the fore. Spanning three intense days, the event was a melting pot of legal acumen, eloquence, and rigorous argumentation. The stakes were high, and the competition was fierce as teams battled it out in a simulated courtroom setting, showcasing their expertise in legal research, advocacy, and critical thinking.

Inaugurating the event with great pomp and enthusiasm was the esteemed Rajasthan High Court Justice CK Songra, whose presence added gravitas to the proceedings and set a tone of excellence for the competition. Furthermore, the valedictory ceremony was graced by the distinguished former Vice-Chancellor of the Dr. B.R. Ambedkar Law University, Dr. UC Sankhala, whose insightful remarks and invaluable experience provided a fitting conclusion to the event, inspiring participants to strive for greater heights in their legal careers.

The rewards for excellence were commensurate with the intensity of the competition. The winners of the competition didn't just walk away with accolades but were also awarded a cash prize of ₹21,000. Additionally, they received a coveted subscription worth ₹81,000 of SCC Online, a significant resource for legal research and reference.
